- Candice Henton – RHS family Consumer Science Teacher – Effective 8/18/2014 – 9/29/14

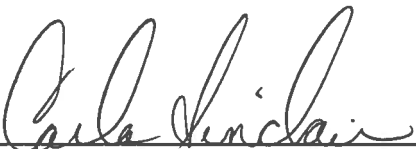
Roll call vote: Yeas- Meeks, Berty, Stone, Ecton, Shew, and Inboden. Nays – none. Motion carried.
