Superintendent Quick told the Board about the damage to the RHS Gym floor. The floor as it is now is not safe for usage. The short term solution would be to remove the flooring down to the concrete in the two areas which are currently buckled. The flooring company will replace the plastic barrier, rubber feet, and underlayment in those areas. They will weave in new maple on the playing surface, touch up the lines as needed, and recoat the playing surface. The company will charge time and materials not to exceed \$20,000 to complete this work. After a lengthy discussion, a motion was made by Greg Bachelor and seconded by Bill Sandiford to approve the short term solution to the RHS gym floor. Roll call vote: Yeas – Meeks, Bachelor, Brown, Stone, Sandiford, Shew and Stone. Nays – None. Motion carried.

Superintendent Quick explained to the Board that the house on North Howard Street had been torn down and the ground had been leveled. Superintendent Quick told the Board that the other house on the property has cracks in its foundation and most likely unable to be sold. The Board asked that IDEAL check for asbestos in the building.
