- Pre-K and Kindergarten Screening will be starting soon

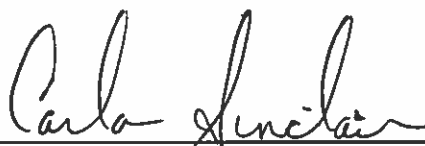
