Dear Incoming 12th Grade Parents:

There are specific regulations set forth by the Illinois Department of Education & the Illinois Department of Public Health to ensure a healthy school life for every student. The necessary forms are enclosed with this letter. They can also be found on our school website at www.robinsonschools.com under the Nurses tab. If you have any questions about these forms, please contact the school nurse at (618) 544-9510 ext 102.

Below is a health requirements checklist, which should be met for every student enrolling in 12th Grade:

Twelfth Grade Students:

- Proof of receiving (2) Meningitis: First dose received on or after the 11th birthday and second dose received at least 8 weeks after the first. Only one dose is required if the first dose was received at 16 years of age or older.

These documents are required by Illinois State Law. Your child will be excluded from school on October 15 of the next school year until the forms have been completed and turned in or you provide a signed letter/appointment card indicating your child has a scheduled appointment.

State of Illinois Health Requirements for the 2025-2026 School Year

Students will **NOT** be able to attend school after **October 15, 2025** until **ALL** required information is received.

Requirements by Grade Level:

Preschool Students:

- Physical Exam
 - Lead Risk must be completed on form by physician
 - Health History must be signed by parent/guardian and verified by health provider
- Complete immunization record signed by a doctor: (4) DTap, (3) Polio, (4) Hib, (3) Hep B, (1) MMR, (1) Varicella, (4) Pneumococcal
- Birth Certificate

Kindergarten Students:

- Physical Exam
 - Lead Risk must be completed on form by physician
 - Health History must be signed by parent/guardian and verified by health provider
- Complete immunization record signed by a doctor: (5) DTap, (4) Polio, (3) Hep B, (2) MMR, (2) Varicella, (4) Pneumococcal
- Dental Exam on IL form due May 15, 2026 (dated within 18 months of May 15th deadline)
- Eye Exam on Illinois form dated within one year of the first day of school
- Birth Certificate

Second Grade Students:

- Dental Exam on IL form due May 15, 2026 (dated within 18 months of May 15th deadline)

Sixth Grade Students:

- Physical Exam
 - Lead Risk must be completed on form by physician
 - Health History must be signed by parent/guardian and verified by health provider
 - **Sports physical NOT acceptable**
- Complete immunization record signed by a doctor, including **(1) Tdap, (1) Meningitis**-these are 6th-grade requirements
- Dental Exam on IL form due May 15, 2026 (dated within 18 months of May 15th deadline)

Ninth Grade Students:

- Physical Exam
 - Lead Risk must be completed on form by physician
 - Health History must be signed by parent/guardian and verified by health provider
 - **Sports physical NOT acceptable**
- Complete immunization record signed by a doctor
- Dental Exam on IL form due May 15, 2026 (dated within 18 months of May 15th deadline)

Twelfth Grade Students:

- Proof of receiving (2) Meningitis: First dose received on or after the 11th birthday and second dose received at least 8 weeks after the first. Only one dose is required if the first dose was received at 16 years of age or older.

October 15, 2025 is the deadline for all required health information!
