President Inboden opened with a public hearing at 6:45pm to hear public opinion on a Summer Food Service exemption waiver for CUSD #2. The waiver will exempt the District from providing a summer food service program. Washington Elementary has over 50% free & reduced ticket students and that requires the District to file the waiver application. There were no comments or questions from the public and the hearing was closed at 6:55pm.

President Inboden called the January board meeting to order at 7:00pm. After roll call and the pledge, a motion was made by Meeks and seconded by Swaner to approve the consent agenda which included: Prior Minutes (12/20/10-Regular and 12/20/10-Closed); along with January 2011 Bills & Payroll, Policy Revisions, Waiver for exemption from summer food program, and request for RHS gym for Jr. wrestling tournament to be held

on February 13, 2011. Roll call vote: Yeas - Swaner, Keeler, Lowrance, Meeks, Ecton and Inboden. Nays – none. Motion carried.

- Principal Hickey commented on the Athletic Conference transition and will have additional information after their meeting on Wednesday January 19, 2011. Lil' Abner Musical is at RHS Cafetorium this Friday and Saturday, January 21<sup>st</sup> and 22<sup>nd</sup>.
- The Board and Administrators discussed their ideas for updating technology in order to develop and promote widespread use of technology as a supplementary enhancement to education.

A motion was made by Keeler and seconded by Ecton to approve a leave of absence for 2<sup>nd</sup> grade teacher Nicole Damron for the approximate dates of March 30, 2011 thru May 4, 2011. Roll call vote: Yeas – Ecton, Lowrance, Keeler, Meeks, Swaner, and Inboden. Nays – None. Motion carried.

A motion was made by Meeks and seconded by Swaner to approve a leave of absence for RHS Health teacher Levi Damron for the approximate dates of March 30, 2011 thru April 11, 2011. Roll call vote: Yeas – Lowrance, Keeler, Swaner, Ecton, Meeks, and Inboden. Nays – none. Motion carried.

A motion was made by Lowrance and seconded by Ecton to approve the following teachers for LGS After-School Tutoring Positions (to be paid by Title I Stimulus Funding): Lori Treadway, Carol Swisher, Judy Walden, Chuck Midgett, Carrie Jensen, and Stephanie Dean. At 8:40pm a motion was made by Keeler and seconded by Ecton to dismiss the January 2011 regular board meeting. Roll call vote: Yeas – Keeler, Lowrance, Ecton, Swaner, Meeks, and Inboden. Nays – none. Motion carried.
