NEW BUSINESS

Superintendent Quick gave a presentation on the 1% sales tax and answered questions presented by the public. After some discussion, the Board decided this tax would be a positive move for the District. The Board approved the Resolution – Consideration and action on a resolution directing the Regional Superintendent of Schools for the County of Crawford, Illinois to certify to the County Clerk of Crawford County the question of imposing a retailers' occupation tax and a service compensation tax to be used exclusively for school facility purposes be submitted to the voters at the consolidated election of April 9, 2013.
