# **UNIT #2 DISTRICT UPDATES/ PUBLIC COMMENT:**

NMS Principal, Craig Beals, commended the 8<sup>th</sup> Grade Language Art Teachers, Diana Thompson and Devan Fuller on their 8<sup>th</sup> grade fire safety unit. They have been teaching this unit for three years. They have been teaching fire safety using the following criteria:

- 1.) Students read the book Ashes of Roses.
- 2.) J. D. Branson, a Marathon employee comes to NMS to speak to the students about fire safety practices at Marathon.
- 3.) Robinson Fire Department comes to NMS and explains home fire safety. The Fire Department brings in fire extinguishers for each student to practice extinguishing a fire in a fire pit.

Wrigley Young, a 9<sup>th</sup> grade RHS Student, gave his personal testimonial on how this fire safety knowledge prevented a kitchen fire at his home. Principal Beals told the Board that NMS has been awarded the Wabash Valley Principals' Award for this project of bridging business with school activities.

# OLD BUSINESS

Superintendent Quick updated the Board on the RHS gym floor. The thermal scans and camera scoping results were inconclusive on their findings. Chad Brown has been helping with moisture monitoring techniques and data collecting.

Brent Rich will be taking moisture readings periodically in various areas of the gym floor.

Superintendent Quick updated the Board on the Pre-K program. The Pre-K Committee met on January 9, 2018 to discuss the current situation with a lack of housing for the ROE #13 Pre-K. Mr. Quick has received an e-mail from Christie Butcher, ROE #12 Pre-K Coordinator, stating that as of now the ROE Pre-K most likely will be working in conjunction with a new Day Care Facility. Pre-K plans for Unit #2 are now placed on hold.
