Superintendent Quick reminded the Board that several committees need to meet in the near future.

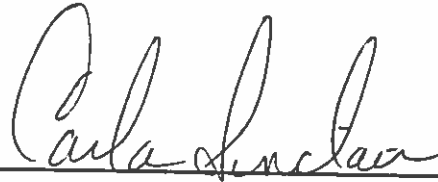
