### OLD BUSINESS

Discussion was held on possible program add-backs or new additions to existing programs. Superintendent Quick has met with School Improvement Teams at LGS and NMS. He will be meeting with RHS and WES in the near future. He will compile the information gathered from all four schools and report back to the Board next month. The Board requested that Superintendent Quick give a

report next month with a priority list, price tag for items, and what the amount of money that can be spent from the budget. Superintendent Quick told the Board the main concern from the schools thus far has been the mental health of our students. Superintendent Quick also suggested that we plug our school demographics into the State Researched Evidence Based Funding Model to see what the areas of need would need to be filled.

A motion to direct the Superintendent to budget, negotiate, and post the proper positions to add High School Co-Ed Soccer, Jr. High Softball, and Jr. High Baseball to our sports programs starting with the 2021-2022 school year was made by Inboden and seconded by Parker. Roll call vote: Yeas – Elliott, Inboden, Parker, Murphy, Stone, and Sandiford. Motion carried.

### **NEW BUSINESS**

A motion was made by Murphy and seconded by Stone to approve the disposition of the closed session minutes as presented. Roll call vote: Yeas – Inboden, Parker, Murphy, Stone, Elliott, and Sandiford. Nays – none. Motion carried.

### **SUPERINTENDENT'S REPORT:**

Superintendent Quick gave the following updates:


- COVID numbers are looking great.
- Superintendent Quick has a weekly call with the Crawford County Health Department.
- COVID vaccinations will be administered to staff as soon as enough vaccine is available. 170 persons are already signed up for the vaccine.
- Health Department will be using the Transportation Facility for the drive-through vaccines.
- Sports have now been moved to Tier One Protocol. Superintendent Quick is waiting on word from the State for the final protocol wording.

**BUILDING AND GROUND REPORT:**

- **Traffic Study – still a work in progress**
- **Facility Usage Report - progress has began and waiting to schedule dates for visits**
- **Health Life Safety Projects – the process has been started to get all projects bid out and finished**
