# PREVAILING WAGE RESOLUTION

Whereas, the State of Illinois has enacted "An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works", approved June 26, 1941, as amended, being Chapter 820 ILCS 130/1-12, Illinois Compiled Statues; and

Whereas, the aforesaid Act requires that the Robinson Community Unit School District #2 investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Robinson Community Unit School District #2 employed in performing construction of public works, for said Robinson Community Unit School District #2; and

Now, therefore, be it ordained by the Robinson Community Unit School District #2, Crawford, Illinois, as follows:

#### SECTION 1

To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works" approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of this Robinson Community Unit School District #2 is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Crawford County area as determined by the Department of Labor of the State of Illinois as of June 2018 a copy of that determination being attached hereto as Exhibit "A" and incorporated herein by reference. The definition of any terms appearing in this Resolution which area also used in the aforesaid Act shall be the same as in said Act.

### **SECTION 2**

Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of this Robinson Community Unit School District #2 to the extent required by the aforesaid Act.

### **SECTION 3**

The Board Secretary shall publicly post or keep available for inspection by any interested party in the main office of this Robinson Community Unit School District #2 this determination of such prevailing rate of wage.

# SECTION 4

The Board Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

#### **SECTION 5**

The Robinson Community Unit School District #2 shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

## **SECTION 6**

The Board Secretary shall cause a notice to be published in a newspaper of general circulation within the area that the determination of prevailing wages has been made. Said notice shall conform substantially to the notice attached hereto. Such publication shall constitute notice that this is the determination of the Robinson Community Unit School District #2 and is effective.
